# THE REGULAR MEETING OF THE BLUE GRASS CITY COUNCIL BLUE GRASS, IOWA OCTOBER 21, 2024

The Blue Grass City Council met in regular session at 7:00 p.m. on the 21<sup>st</sup> day of October 2024, in the City Council Chambers of City Hall, 114 N. Mississippi Street, Blue Grass, Iowa, pursuant to law, with Mayor Brad Schutte presiding, with a Pledge of Allegiance and a moment of reflection.

**APPROVAL OF AGENDA:** Smith moved to approve the Agenda as presented, seconded by Bowman. Roll call: Smith-aye, Bowman-aye, Brandenburg-aye, Blok-aye and Hermann-aye. Motion carried.

Request for dumpster:** The Clerk referred to Section 8.14 Refuse Disposal in regards to residential family dwelling units as landlord Mike Arp was requesting to have a dumpster at his 4-plex apartment building to eliminate having 8 carts as it was becoming a nuisance; however, according to the Code in order to have a dumpster, the unit must have more than four units. Discussion was held. Brandenburg moved to allow Mike Arp to have a dumpster due to his lot size, seconded by Bowman. Roll call: Brandenburg-aye, Bowman-aye, Smith-aye, Blok-aye and Hermann-aye. Motion carried.
- **16. Clerk's Report:** City Clerk Ann Schmidt presented the August 2024 Clerk's Report.

**COMMENTS AND FUTURE AGENDA ITEMS:** Smith inquired about having a fire pit since Scott County was under a burn ban. Chief Seamer said yes as long as the fire pit has a wire mesh over it and there was water near the vicinity.
