THE REGULAR MEETING OF THE BLUE GRASS CITY COUNCIL BLUE GRASS, IOWA DECEMBER 15, 2025

The Blue Grass City Council met in regular session at 7:00 p.m. on the 15th day of December 2025, in the City Council Chambers of City Hall, 114 N. Mississippi Street, Blue Grass, Iowa, pursuant to law, with Mayor Brad Schutte presiding, with a Pledge of Allegiance and a moment of reflection.

Council present: Blok, Brandenburg, Hermann and Smith. Absent was member Bowman.

SWEARING IN OF MAYOR ELECT: City Clerk Ann Schmidt administered the Oath of Office swearing in Mayor elect Brad Schutte for a 2-year term.

SWEARING IN OF CITY COUNCIL MEMBERS: Mayor Schutte administered the Oath of Office to reelected Council members Mike Hermann and Cheryl Smith both for 4-year terms.

APPROVAL OF AGENDA: Smith moved to approve the Agenda with the deletion of items #15 & #16 as they are duplicates and remove Dawn Greer's appointment as her term does not expire until 2029, seconded by Blok. Roll call: Smith-aye, Blok-aye, Brandenburg-aye and Hermann-aye. Motion carried.

Mayor Schutte read aloud the Mayoral Comments.

PUBLIC FORUM: From those in attendance, there were none.

CONSENT AGENDA: Blok moved to approve the Consent as presented, seconded by Smith.

11. Nuisance Abatement(s): Mayor Schutte commended Public Works on their snow removal as they did a great job; however, it has been reported that Public Works has been approached by several residents

complaining and/or throwing items at them reporting that the City has a zero-tolerance policy and the Police Chief will be addressing these issues. Council commended Public Works on their promptness in removing the snow from the City Streets.

12. Status of Demolition Project: Mayor Schutte reported that the utilities have already been shut off and the asbestos has been taken care off reporting that the weather had delayed the demolition.

ECONOMIC DEVELOPMENT:

20. Strategic Planning & Goal Setting: The Clerk reported that the City's Bonding Attorney was in the process of drafting the proceedings to approve a tax abatement for Brus Construction with public hearings to be held in January and February.

Brandenburg expressed financial concerns on proceeding with the reconstruction of East Telegraph Road as it is projected to cost anywhere between \$3M to \$5M stating that he is not in favor of putting Blue Grass in a financial bind and borrow that amount of money as this project has been discussed since he was Mayor back in 2015 and beyond that. Discussion was held as the Engineer had recently put together a proposal for services, exhibit and preliminary cost estimate. The Clerk reported that this proposal would be placed on the January 5, 2026 meeting agenda.

COMMENTS AND FUTURE AGENDA ITEMS: From those in attendance, there were none.

ADJOURNMENT: Brandenburg made a motion to adjourn, seconded by Smith. Roll call: Brandenburgaye, Smith-aye, Blok-aye and Hermann-aye. Motion carried. The meeting was adjourned at 7:30 p.m.
