>	Golf Carts are not allowed to trav- sunrise and sunset.	Solf Carts are not allowed to travel on US Highway 61 and shall only be operated between the hours of sunrise and sunset.				
>	The number of occupants shall not exceed the seating capacity recommended by the manufacturer. While operating, any rider must be seated on the seat and no part of the body of any rider will extend eyond the sides of the cart.					
>	All operators shall observe all state and local traffic regulations and at no time parked upon city sidewalks or recreational trails.					
>	No Golf Cart shall be operated while under the influence of intoxicating liquor, narcotics or illegal drugs.					
>	No person shall operate a Golf Cart in a careless, reckless, or negligent manner endangering the person or property of another or causing injury or damage to the same.					
>	All Golf Carts shall be equipped with a minimum of the following safety features: A slow-moving vehicle sign, a safety flag which the top shall be a minimum of five (5) feet from the ground level, adequate breaks. Golf Carts are required to have a rear-view mirror.					
•	weighing less than twenty pounds shall be secured during transit in a rear-facing child restraint system that is used in accordance with the manufacturer's instructions. A child under six years of age who does not meet the description in paragraph "A" and shall be secured during transit by a child restraint system that is used in accordance with the manufacturer's instructions. A child at least six years of age but under eighteen years of age shall be secured during transit by a child restraint system that is used in accordance with the manufacturer's instructions or a safety belt or safety harness of a type approved under lowa Code 321.445.

>		The permit may be revoked upon finding evidence that the owner of operator has violated the conditions of the permit or has abused the privilege of being a permit holder. Permits expire annually from the date of issuance.
