## **Chapter 15.04**

### **BUILDING CODE**

**Add Sections:**

- 15.04.025 Contractor - Registration Required.**
- 15.04.026 Contractor - Registration Exemptions.**

**15.04.025 Contractor - Registration Required.**

All contractors performing construction work within the corporate limits of the City of Blue Grass must be registered with the City and must be registered with the State of Iowa Division of Labor at 1000 E. Grand Avenue, Des Moines, IA 50319 1-800-562-4692. Contractors must register annually on a form provided by the City Clerk/Financial Officer with an annual fee of seventy-five dollar (\$75.00). Registrations are valid from January 1 to December 31, fees will not be prorated or refunded. Contractors are also required to provide both a Certificate of Liability Insurance naming the City of Blue Grass as certificate holder and submit in original form a Contractors Code Compliance Bond provided by the City Clerk/Financial Officer in the amount of ten thousand dollars (\$10,000.00). Contractors are responsible to renew their registration annually and to include new copies of both the Certificate of Liability Insurance and Bond. No holder of a valid license shall obtain a permit under his/her license and then subcontract, sell or otherwise assign the work covered by the permit to a person or firm who does not have a valid license. Contractors doing permitted work are expected to know when inspections are required. Necessary inspections may vary based on the scope or work being performed.

**15.04.026 Contractor - Registration Exemption.**

No license is required for the homeowner(s) of an existing residential dwelling. All work must be performed solely by the owner(s) or an immediate family member. Prior to issuance of a building permit, the Building Commissioner shall inspect the repair and/or remodel project to determine whether the homeowner(s) has demonstrated the knowledge and ability in the area of work for which the homeowner(s) has applied. It shall be at the discretion of the Building Commissioner to issue a building permit. (Amd. 20-03, eff. 11/30/20)

Binding oneself, in the penal sum of \$10,000.00 with the surety to the approval of authorized authority, conditioned for the performance of its contractual work, in accordance with provisions of this Bond for all work performed under said license and for the faithful compliance with the provisions of Chapter 15.04 of the Blue Grass Municipal Code. This Bond is a continuous Bond and shall remain in full force and effect until canceled by notice. The surety shall have the right to cancel this Bond for future liability upon thirty (30) days written notice to the City of Blue Grass.
